CONSENT AGENDA

What is a consent agenda?

A consent agenda is made up of items that may be considered routine business that need action, but are unlikely to require debate. Items for inclusion on the consent agenda must be sent out in advance with the pre-presbytery mailing and clearly marked for the consent agenda.

Why is a consent agenda useful?

When the consent agenda is called for, the moderator will call for a motion to approve the entire consent agenda in one vote, thus saving presbytery time for items requiring more discussion.

BUT What if I wish to debate, discuss, ask for clarification on some part of the consent agenda?

Simply, rise to be recognized and request that that item be removed from the consent agenda. One person's request is all that is required. No second is required; no vote need be taken to remove the item.

Do not give the explanation of your concern, need for clarification, points to be emphasized or opposed at this time. The item will come up for consideration at the time when the remainder of that committee's report is made, and you will be afforded the opportunity to speak to the motion at that time.

COMMITTEE ON REPRESENTATION REPORT 2025

The Presbytery of Huntingdon, located in central Pennsylvania, is made up of six counties. The most recent population data (2020) indicates low ethnic diversity.

The largest ethnic group in all six counties is **white**, **non-Hispanic**, ranging from 85.3% to 96.5%. Two counties have a second ethnic group greater than 5 %:

- Centre County, where Penn State University is located, has 85.3% white, non-Hispanic and 6.23 % Asian.
- Huntingdon County, where Juniata College is located, has 90.3% white, non-Hispanic and 5.23% Black or African American.

None of the households in all six counties reported speaking a non-English language at home as their primary shared language.

Encouraging inclusion and diversity in central Pennsylvania begins with education and exposure. We have two Asian ministers in our presbytery; one is active in presbytery and synod committees and the other has just joined our presbytery this spring. She is eager to become more involved in our presbytery. The Committee on Representation and Nominating Committees will continue to press the Presbytery to be not only inclusive but to encourage the communities we live in to also welcome persons of diverse backgrounds.

Broadband internet is a tool to use to spread and live the Good News by strengthening our connections to each other and within our communities. This makes broadband accessibility a critical need and major concern for churches and the communities they serve. Internet connections throughout the presbytery have improved. Most presbytery committee meetings are currently held on Zoom. Presbytery meetings are generally hybrid to allow both in-person and online participation. Many churches who began live-streaming worship, have continued to do that to enable home-bound members and those who have relocated to stay connected to their faith communities.

 - o 5 CLPs serving in Huntingdon Presbytery and 1 serving in another presbytery o 18 additional Certified Lay Preachers on the Approved Pulpit Supply list

COMMITTEE ON MINISTRY REPORT November 11, 2025

FOR ACTION:

1. Nathan Koozer & First Presbyterian Church Alexandria & Bellwood Logan Valley: That Presbytery *grant* the request of the sessions of the First Presbyterian Church of Alexandria and Logan Valley Presbyterian Church of Bellwood to approve the renewal of their temporary supply contract with Candidate Nathan Koozer for the purpose of providing pastoral leadership. The contract is for up to twelve months to begin January 1, 2026.

Summary of contract: The following agreement between the Presbytery of Huntingdon, the Session of the Alexandria Presbyterian Church; the Session of the Logan Valley Presbyterian Church, and Nathan Koozer. Other parties to this agreement are Pittsburgh Theological Seminary and the SubCommittee on Preparation for Ministry of the Presbytery of Huntingdon, under whose care Nathan Koozer is a Candidate. This contract is for the purpose of providing pastoral leadership as a Seminary Student in Preparation for Ministry and Service in Covenant Relationship.

I. **Elements:** Upon the approval of the Presbytery of Huntingdon, through the Committee on Ministry, Nathan Koozer will be Student Intern Pastor of the Alexandria Presbyterian Church and the Logan Valley Presbyterian Church.

II. Terms of Employment

- **a. Time commitment**: This contract is intended to be fulfilled in 87.5% time. This will be allocated 50% to Alexandria and 37.5% to Logan Valley.
- **b.** Length: The Student Intern contract will run from January 1, 2026 to January 1, 2027 and shall not exceed twelve months. Extensions may be granted when endorsed by the Session(s), the Student Intern, the Committee on Ministry, and the student intern's Committee on Preparation for Ministry.
- **c. Termination**: The work agreement may be terminated with a 30-day written notice by the Student Intern or a Session, upon the approval of the Committee on Ministry. The contract may also be terminated by the Committee on Ministry.

IV. **Accountability and Evaluation:** The Student Intern is accountable to the church through the Session and to the Presbytery through the Committee on Ministry.

- V. The Student Intern may officiate at the Sacrament of the Lord's Supper, but will not officiate at the Sacrament of Baptism or weddings or moderate sessions. Rev. Carl Campbell remains moderator of Alexandria and Rev. Barry Vance remains moderator of Logan Valley. They will be the student intern's mentors.
 - 2. Rev. Mary Jo Bruinooge & St. John Lutheran of Clearfield: That presbytery approve the amendment of the pastoral services contract between the Rev. Mary Jo Bruinooge & St. John Lutheran Church of Clearfield, beginning November 1, 2025, for up to twelve months.

"Be shepherds of God's flock that is under your care, watching over them—not because you must, but because you are willing, as God wants you to be; not pursuing dishonest gain, but eager to serve; not lording it over those entrusted to you, but being examples to the flock." (1 Peter 5:2-3)

With the prayerful guidance of this passage from I Peter, I offer the following possibility to serve our Lord with the people of St. John Lutheran Church, Clearfield, PA as a *Pastoral Shepherd*.

Responsibilities (per week):

- Worship Leadership Sunday mornings and Saturday evenings
- Office Hours 1 morning per week (2-3 hours) and as needed
- Emergency Visitation (with an accompanying church member)
- Misc. pastoral services as needed (ie, weddings, funerals, baptisms)
- Additional duties as negotiated
- Meetings as needed

Other terms of service:

- This covenant may be ended with 30 days notice by the pastoral shepherd, the council, or the presbytery via the Committee on Ministry of Huntingdon Presbytery.
- All clearances with Pennsylvania will be current and on file
- Schedule of Worship leadership, meetings and such to be in collaboration with the church's leadership council via the council president. Activities will be logged and reviewed at monthly staff meeting with the council president and as needed.
- This covenant will be reviewed on a yearly basis or as needed
- This covenant is effective November 1, 2025

3. Adam Clever & Philipsburg Presbyterian Church

- a. That presbytery examine the Rev. Adam R. Clever, a teaching elder member in good standing of Kiskiminetas Presbytery, for membership in the Presbytery of Huntingdon, and approve the call of the Philipsburg Presbyterian Church of Philipsburg, PA to the Rev. Adam R. Clever to be its full-time pastor, effective November 30, if the way be clear. The congregation will meet on November 9 to consider the call. All background checks and certificate of Mandated Reporter training must have been received.
- b. That presbytery authorize Committee on Ministry to set a time and form an administrative commission to install the Rev. Adam Clever as pastor of the Philipsburg Presbyterian Church.
- c. That presbytery dismiss ruling elder Kate Sillman as moderator of Philipsburg Presbyterian Church, effective with the installation of Rev. Clever, with thanks.

ADAM R. CLEVER STATEMENT OF FAITH

God's full nature is a mystery beyond the reach of the human mind. God exists as one God, perfectly united. God exists as Three Persons: Father, Son, and Holy Spirit. All are eternal, the Creator of all. All are active in our Redemption, overcoming death, evil, and sin to make us right with God. All three are active Sustainers, beside us every step of life's journey.

The scriptures of the Old and New Testament are the "unique and authoritative witness" to who this God is. Through the scriptures, through the prophets, through the Spirit, and through the Incarnation God has chosen to reveal to us who God is, that we might come to know our Creator and Lord.

Although the Son is eternally God from the beginning, he most directly intersects with human history in the life of the man Jesus of Nazareth. In this incarnation, the second person of the Trinity became fully human. The Incarnation is the pinnacle of God's desire to reveal God to humanity. Through the human Jesus, we can know God in human terms. He became all that we are. He was hungry and thirsty; he wept, learned, struggled, prayed, and suffered. He died a human death, and then rose in divine glory. He ascended into heaven, where he reigns in power. He will come again to bring reconciliation and restoration to the world.

In the death, resurrection, and ascension of Jesus, we find the assurance that our sins are forgiven, the brokenness of creation is mended, and God has opened the path to eternal life for all who follow Christ. Jesus is likened to the redeemer who pays the debt to free us from slavery, to the sacrificial lamb whose blood cleanses the altar and the people of Israel, to the Passover lamb whose blood marked the homes of those who trusted in God so that the angel of death might pass over those homes, to the high priest who intercedes on our behalf and offers the blood before God in the Temple, and to the one who suffers on our behalf, bearing the punishment we earned by our misdeeds. Jesus calls us to love God and our neighbors, to help the needy, and to spread the Gospel. Nevertheless, Salvation, resurrection, and eternal life in Christ are gifts from God, brought to us by the redeeming work of Jesus Christ.

Since ancient times, God has called out a community of people to be God's followers on earth. As the heirs of Israel and of the Apostles, the Christian Church is the chosen body of God's people. While we continue to fail at times, just as Israel did and the disciples did, God continues to be faithful. Christ offers salvation and redemption to his followers, but also to the world. God does not offer us eternal life in some abstract heaven. God promises us a restored heaven and earth, with the Lord in our midst. While it is true that each of us can call Jesus our personal Lord and Savior, Jesus is also the universal Lord and Savior of all.
