Directions to State College:

All participants are urged to park in the Beaver Ave parking garage across the street from the church. (Use elevator/stairs at the south end directly across from the post office.) Parking is 75 cents an hour. Handicapped access is available either from the main doors on the alley (by the Post Office and opposite the parking garage). Or from the Beaver Ave. metered parking lot side through the lower level doors at the front and the elevator to the sanctuary level. Only those requiring handicapped/disabled parking should park in the unmetered row of parking spaces next to the church on the east side. As a bonus, State College PC will provide registered participants vouchers good in the Beaver Ave. Parking garage for three hours free time.

From I-80: Take Exit #158 toward Milesburg. Follow PA #144 to Bellefonte (Water Street). Continue straight ahead on PA #150 to the State College Mall. Continue straight ahead on PA #26 to downtown State College. At the Atherton St. intersection, turn left onto Atherton. Turn left at the next light (Beaver Ave.) Go a block and a half, and turn right into parking garage.

From Philipsburg: Take US #322 east to State College. Take the business #322/North Atherton Street exit. The exit ramp becomes North Atherton Street. Take Atherton to the center of State College. One block beyond College Ave., turn left on Beaver Ave. Go a block and a half, and turn right (middle of the block) into parking garage

From east: Take US #322 west to State College. Take the #322 business exit through Boalsburg. #322 becomes South Atherton Street. Take Atherton to the center of State College. Turn right on Beaver Ave. Go a block and a half, and turn right (middle of the block) into parking garage

From southwest of presbytery: Take #45 east from Tyrone through Warrior's Mark to Seven Stars. [This is also #550 to Warrior's Mark, and #350 to Seven Stars.] Left on #45, to Pine Grove Mills. From the light in Pine Grove, follow #26, which is College Avenue. In State College, follow the jog (when #26 becomes one way) to Beaver Avenue. Follow Beaver Avenue across Atherton Street. Go a block and a half, and turn right into parking garage. Note: Many may find that taking I-99 to State College, while slightly more miles, is shorter in time and stress. If you take I-99, exit I-99 at business #322/N. Atherton Street and follow the Philipsburg directions.

From south of presbytery: Take #26 from Huntingdon to Pine Grove Mills. From the light in Pine Grove, follow #26, which is College Avenue. In State College, follow the jog (when #26 becomes one way) to Beaver Avenue. Follow Beaver Avenue across Atherton Street. Go a block and a half and turn right into parking garage.

CONSENT AGENDA

What is a consent agenda?

A consent agenda is made up of items that may be considered routine business that need action, but are unlikely to require debate. Items for inclusion on the consent agenda must be sent out in advance with the pre-presbytery mailing and clearly marked for the consent agenda.

Why is a consent agenda useful?

When the consent agenda is called for, the moderator will call for a motion to approve the entire consent agenda in one vote, thus saving presbytery time for items requiring more discussion.

BUT What if I wish to debate, discuss, ask for clarification on some part of the consent agenda?

Simply, rise to be recognized and request that that item be removed from the consent agenda. One person's request is all that is required. No second is required, no vote need be taken to remove the item.

Do not give the explanation of your concern, need for clarification, points to be emphasized or opposed at this time. The item will come up for consideration at the time when the remainder of that committee's report is made, and you will be afforded the opportunity to speak to the motion at that time.

[Presbytery shall review annually the work of all teaching elders engaged in validated ministries outside the congregation. G-2.0503a]

2. **Members at large:** that presbytery grant the following minister members of presbytery member at large status: Bob Hicks Peggy Lindsey [*Presbytery shall review annually the status of members-at-large. G-2.0503b*]

- 3. Annual review of laboring within the bounds: That presbytery authorize the following to labor within our bounds as Approved Pulpit Supply: Rev. Peggy Bonsell (United Methodist); Rev. James Bricker (ELCA); Mr. David Dimmick (United Methodist); Mr. Darwin Goshorn (United Methodist); Rev. Charles Gummo (United Methodist); Rev. Richard Henry (United Church of Christ); Rev. Mark Liller (Church of the Brethren); Ms. Beverly Skopic (Church of the Brethren); Rev. Nathan Starr (Church of God); Rev. Charles Stump (Christian Missionary Alliance).
- **4. Labor outside the bounds**: That presbytery authorize the following to labor outside our ecclesiastical bounds: Anne Ard as Centre Safe Executive Director, Al Holtzinger, Jr., as commissioned lay pastor of Altoona Grace United Church of Christ; Tom Poole as educator at Penn State, and Ela J. Robertson, as pastor of the St. John's Lutheran Church; Dennis Braun as chaplain at UPMC-Altoona; and Harold Williams, as Westminster Woods chaplain.

5. Juniata and ruling elder Janet Kephart:

- a. That presbytery approve the request of the session of the Altoona Juniata Presbyterian Church for a temporary supply relationship between ruling elder Janet Kephart and the session of the Altoona Juniata Presbyterian Church, beginning February 1, 2020 for up to twelve months.
- b. That presbytery grant a commission to ruling elder Janet Kephart to be commissioned ruling elder and commissioned lay pastor of the Juniata Church for a period of up to twelve months, beginning February 1, 2020. The commissioned lay pastor remains a member of the Osceola Mills Presbyterian Church.
- c. That presbytery authorize ruling elder Janet Kephart as the commissioned lay pastor of the Juniata Presbyterian Church to administer the Lord's Supper, administer the sacrament of baptism, moderate the session and congregation, and have voice and vote in meetings of presbytery (such vote to be counted as a ruling elder commissioner).
- d. That presbytery appoint ruling elder Janet Kephart as moderator of the Juniata Presbyterian Church for the duration of her commission, beginning February 1, 2020.
- e. That presbytery authorize ruling elder Janet Kephart as commissioned lay pastor to perform a service of Christian marriage of members of her congregations or of the local community when invited by

the session. Such service may only be performed within the geographical bounds of the presbytery. In performing such service of Christian marriage, the commissioned lay pastor shall follow all provisions of the Directory for Worship regarding marriage.

Note: The Rev. Rob Bruinooge remains the commissioned lay pastor's mentor.

Summary of terms of service.

SPECIFIC RESPONSIBILITIES OF PASTOR

- A. **Worship:** Lead worship on Sundays, plus special services including services on Christmas Eve and Maundy Thursday.
- B. **Visitation:** The commissioned ruling elder will, with the help of session, determine a visitation schedule of those that are shut-ins, hospitalized and nursing home residents. Visitation will be a joint effort of members and commissioned ruling elder.
- C. **Sacraments:** The commissioned ruling elder will officiate at baptisms and the Lord's Supper. The commissioned ruling elder will take communion, if requested, to the homebound, with an accompanying ruling elder.
- D. Weddings and funerals. The commissioned ruling elder is authorized to perform a service of Christian marriage of members of the congregation or of the local community when invited by the session. Such service may only be performed within the geographical bounds of the presbytery. In performing such service of Christian marriage, the commissioned ruling elder shall follow all provisions of the Directory for Worship regarding marriage. As pastor, the commissioned ruling elder has the privilege of first refusal of any wedding or funeral held at the church.
- E. Administration: To provide active leadership to the session and congregation as moderator.
- F. **Presbytery:** To attend presbytery meetings and presbytery-sponsored lay pastor training events.

Financial Terms of Service

- A. Cash salary: \$175 per week. \$485 per month to be considered housing. This is based on ten hours per week.
- B. Car allowance: Mileage at presbytery-approved rate, currently \$.575 per mile
- C. Continuing education: The commissioned ruling elder is encouraged to engage in continuing education.
- D. Vacation: One month vacation per year, calculated at half time, including at least four Sundays.

TERMINATION, SEVERANCE, AND EXTENSION OF CONTRACT

A. Any party to this agreement may terminate this contract upon thirty days written notice to the other. Notice is to be delivered in person or by certified mail.

6. **Bellwood Logan Valley & the Rev. Charles Curley**: that presbytery concur in the request of the session of the Logan Valley Presbyterian Church and The Rev. Chuck Curley to extend the temporary supply contract between the Rev. Charles Curley and the session of the Logan Valley Presbyterian Church, beginning January 1, 2020, for up to twelve months. Rev. Curley remains moderator of the session. (*See COM minutes, December 11, 2019, Appendix A, pp. 96-97, for full terms of contract.*)

7. **MountainTop Parish & Ruling Elder Leanne Gill Peters:** that presbytery concur in the request of the MountainTop Parish to approve the extensions of the temporary supply relationship between ruling elder Leanne Gill Peters and the MountainTop Parish Council and the sessions of the Grace United and Fruit Hill Presbyterian Churches, beginning February 1, 2020 for twelve months. (*See COM minutes, December 11, 2019, Appendix A, pp. 94-96, for full contract.):*

a. Summary of Terms of service:

Cash salary: On the Sundays when the part time CLP is serving as worship leader and when special worship services are scheduled salary payment will be \$300 per week. On weeks the CLP is not leading worship services the salary payment will be \$225 per week. One third of the total salary is designated as housing allowance.

Other financial terms:

Car allowance: Mileage at IRS and presbytery-approved rate.

- Continuing education: The commissioned ruling elder is encouraged to engage in continuing education. Participation in events beyond one-day workshops should be determined in advance in consultation with the Council. Reimbursement of costs associated with continuing education should be negotiated in advance with Council.
- Vacation: One month vacation per year, calculated at half time, including at least four Sundays.

One half of the SECA costs will be paid by the Parish.

- **b.** That presbytery approve the renewal of the commission to ruling elder Leanne Gill Peters to be commissioned lay pastor and temporary supply of the MountainTop Parish Churches for a period of up to twelve months, beginning February 1, 2020. The commissioned lay pastor remains a member of the Grace United Presbyterian Church.
- c. That presbytery authorize ruling elder Leanne Gill Peters as the commissioned lay pastor of the MountainTop Parish to administer the Lord's Supper, administer the sacrament of baptism, moderate the sessions of the Grace United and Fruit Hill Presbyterian Churches, and have voice and vote in meetings of presbytery (such vote to be counted as an elder commissioner).
- d. That presbytery re-appoint ruling elder Leanne Gill Peters as moderator of the sessions of the Grace United and Fruit Hill Presbyterian Churches and the MountainTop Parish Council for the duration of her commission, beginning February 1, 2020.
- e. That presbytery authorize ruling elder Leanne Gill Peters as commissioned lay pastor to perform a service of Christian marriage of members of her congregations or of the local community when invited by the session. Such service may only be performed within the geographical bounds of the presbytery. In performing such service of Christian marriage, the commissioned lay pastor shall follow all provisions of the Directory for Worship regarding marriage.

TERMINATION: Any party to this agreement may terminate this contract upon thirty days written notice to the other.

The Rev. Katie Hopper remains the commissioned lay pastor's mentor and supervisor.

8. Tyrone & the Rev. Mark Liller: that presbytery extend the temporary supply contract between the Rev. Mark Liller and the session of the Tyrone Presbyterian Church, for up to twelve months, effective April 1, 2020. The Rev. Doug McGaffin continues as moderator. The Rev. Mark Liller is a minister member in good standing of the Middle District of the Church of the Brethren and has the permission of his district to serve our church.

Summary of terms of service: (See COM minutes, December 11, 2019, Appendix A, pp. 97-101, *for full terms of contract.*)

This is a 2/3 time contract, assuming the workweek to be 27 hours. Additional hours to be negotiated as needed by Pastor and Session with compensation paid at a rate at least equal to \$15.00/hour.

Medical insurance coverage will be from Rev. Liller's wife's medical plan. The session will reimburse the amount of dependency medical costs.

Termination clause of thirty-days notice by any of the parties.

9. Belleville West Kish & Belleville St. John's and the Rev. Ela J. Robertson: that presbytery approve the renewal of the full-time contract of the session of the Belleville West Kishacoquillas Presbyterian Church and the council of the Belleville St. John's Lutheran Church for temporary pastoral services with Rev. Ela Robertson, effective January 1, 2020, if the way be clear. (See COM minutes, December 11, 2019, Appendix A, p. 102, for full terms of service.) Ms. Robertson will serve half-time in each congregation. St John's will reimburse West Kish Presbyterian for its share of her salary and benefits package.

Terms of service: This contract will be for a period of one year and may be renewed annually. Each congregation will be responsible for 50% of the total cost.

- **Termination:** This agreement may be terminated upon 60 days' notice given either by the session of the West Kishacoquillas Presbyterian Church, the council of the St. John's Lutheran Church, the temporary supply pastor, the Committee on Ministry of the Presbytery of Huntingdon, or the Lutheran bishop. If notice is given by other than the temporary supply pastor, thirty days of additional severance pay will also be given.
- 10. Rev. Helen Kester: That the Rev. Helen Kester be honorably retired effective January 1, 2020.
- 11. **Commissioned pastor Martha Bloom & Winburne**: that presbytery dissolve the contract between Commissioned Lay Pastor ruling elder Martha Bloom and the session of the Winburne Presbyterian church, effective December 31, 2019 and grant her honorable retirement as a lay pastor. She remains a certified lay preacher.

12. Commissioned pastor Gary Jewart & Curwensville: that presbytery

- a. grant the extension of the temporary supply contract for pastoral services between ruling elder Gary Jewart and the session of the Curwensville Presbyterian Church for a period of up to twelve months, beginning January 1, 2020.
- b. approve the renewal of the commission to ruling elder Gary Jewart to be commissioned lay pastor and moderator of the Curwensville Church. The commissioned lay pastor remains a member of the Curwensville United Presbyterian Church.
- c. authorize ruling elder Gary Jewart as the commissioned lay pastor of the Curwensville Presbyterian Church to administer the Lord's Supper, administer the sacrament of baptism, moderate the session of the Curwensville Presbyterian Church, and have voice and vote in meetings of presbytery (such vote to be counted as a ruling elder commissioner).
- d. authorize ruling elder Gary Jewart to perform a service of Christian marriage of members of the congregation or of the local community when invited by the session. Such service may only be performed within the geographical bounds of the presbytery. In performing such service of Christian marriage, the commissioned lay pastor shall follow all provisions of the Directory for Worship regarding marriage.
- e . The agreement may be terminated by any party by giving 30 days written notice from the session or from the commissioned lay pastor or from the Committee on Ministry.

The Rev. Chuck Swenson and Reverends Jimmy and Katie Hopper remain the commissioned lay pastor's mentors and supervisors. (*Full terms of service in COM, December 11, 2019, Appendix A, p. 103.*)

- b. That presbytery authorize ruling elder Gary Jewart as the commissioned pastor of the Winburne Presbyterian Church to administer the Lord's Supper, administer the sacrament of baptism, moderate the session of the Winburne Presbyterian Church, and have voice and vote in meetings of presbytery (such vote to be counted as a ruling elder commissioner).
- c. That presbytery re-appoint ruling elder Gary Jewart as moderator of the session of the Winburne Presbyterian Church for the duration of his commission, beginning January 1, 2020.
- d. That presbytery authorize ruling elder Gary Jewart to perform a service of Christian marriage of members of the congregation or of the local community when invited by the session. Such service may only be performed within the geographical bounds of the presbytery. In performing such service of Christian marriage, the commissioned pastor shall follow all provisions of the Directory for Worship regarding marriage.
- e. The agreement may be terminated by any party by giving 30 days written notice from the parish council or from either co-commissioned pastor or from the Committee on Ministry.
- f. That presbytery re-appoint the Rev. Chuck Swenson, Rev. Jimmy Hopper, and Rev. Katie Hopper as the commissioned pastor's mentor and supervisor.

Expectations of co-CLPs:

Time expectations are 10 hours per week.

Conduct 48 Sunday worship services per year, plus special services on Ash Wednesday, Maundy Thursday, Good Friday, Easter sunrise, and Christmas Eve.

Visit shut-ins, hospitalized members, and nursing home residents.

Officiate at baptisms, Lord's Supper and funerals

Moderate session and congregational meetings, normally alternating meetings.

Terms of service as follows:

Salary: \$185 per week,
Vacation: one month, including at least four Sundays, accrued monthly.
Study leave: seven days per year (dates and content set in consultation with Winburne session)
Continuing Education allowance: up to maximum of \$500 accumulated up to three years. Per request and approval by Winburne session. To be reimbursed by voucher.
Book allowance of \$300
One week for Governing Body Service (beyond normal committee or task force work and stated meetings)
Car allowance: travel expenses at current I.R.S. standard
SECA reimbursement: 7.65 percent of cash salary.

- 1. **Rev. L. Tyler Downing & Petersburg Bethel Presbyterian Church**: At the request of the pastor and the congregation, COM dissolved the call of the Petersburg Bethel Presbyterian Church and the Rev. Tyler Downing, effective December 31, 2019, and declared him honorably retired effective the same date.
- 2. **Rev. Dean Lindsey**: COM approved the sabbatical plan of the Rev. Dean Lindsey to visit the islands of Kirabati to study the effect of climate change. He will be gone three months. COM appointed the Rev. Michael Ozaki as moderator of the State College Presbyterian Church, January through March 2020 in Rev. Lindsey's absence.
- 3. **Upper Spruce Creek:** The Rev. Carl Campbell has been appointed moderator of Upper Spruce Creek Presbyterian Church.
- 4. **Rev. Christina Trimble**: The Rev. Christina Trimble was transferred to the Presbytery of Providence, effective November 9, 2019.

The Committee on Preparation for Ministry recommends:

1. Certification of lay preachers: That presbytery certify the following as lay preachers and grant them permission to officiate at the Sacrament of the Lord's Supper with the help of their pastors: Nancy Bostian, Scott Kretchmar, Terry Musser, Tricia Noonan, and Ken Raney.

For information:

1. **Gerald Branthoover**: Certified Lay Preacher Gerald "Jerry" Branthoover died November 15, 2019. He was a member of the Winburne Presbyterian Church.

National lay pastor conference: COM voted to send as many of our three commissioned lay pastors to the first Commissioned Lay Pastor Conference at Canyon Creek Presbyterian Church, Richardson, Texas,

May 12-16, using funds from the Gloria Jean Smith Scholarship Fund.

OVERTURES

A provision in the Book of Order (G-3.0302d) requires that proposed overtures receive a concurrence (or second) from another presbytery. In order to determine whether or not our presbytery wishes to concur with any proposed overture, the stated clerk has emailed copies of all overtures as they came in to clerks of session and teaching elders.

The Committee on Presbytery Life created a Working Task Group to review the overtures presented so far. The Committee met in mid-December. Other overtures have been posted in January. The recommendations of the WTG are as follows:

The WTG recommends that our presbytery consider for concurrence only those overtures which have not received a concurrence from another presbytery because the purpose of the concurrence is <u>solely</u> to make the proposed overture General Assembly business.

The WTG has reviewed the overtures which were proposed by the cutoff date of Wednesday December 4. The deadline for submission of overtures for consideration by the 223rd General Assembly is February 21 for those with constitutional implications and April 21 for those without constitutional implications, but with financial implications. The full text of all overtures may be found on the 224th General Assembly website pc-biz. Go to <u>www.pc-bix.org</u>

The WTG recommends that presbytery concur in overtures 4, 8, 9, 10, 14. A summary of the overtures recommendations and a brief rationale is found below.

Overture 4: On Forming a Commission to Write a New PC(USA) Confession. The proponents feel a need for a confession that makes clear what does it mean to be human in the 21^{st} century. The WTG feels it would be good to have the debate and thought on the topic.

Overture 8: *Regarding the Treatment of Refugees*. The proponent have urged advocacy and for the provision of a toolkit for local congregation action for reasonable and compassionate treatment of refugees. Seemed reasonable to the WTG.

Overture 9: On Advocating for Reduction of Firearm Violence. The WTG does not necessarily endorse the position of the proponents, which is to advocate for red flag laws to allow a court to intervene by removing weapons from a household when someone shows warning signs of impending violence, but the WTG would like to see the topic of response to violence discussed.

Overture 10: On Designating May 15 as the Palestinian Nakba Remembrance Day. The proponents call for prayer for peace in Palestine, for solidarity with those suffering under occupation, and for advocacy among PC(USA) members, with the inclusion of Palestinian Nakba Remembrance on May 15 in the Presbyterian Planning Calendar. The WTG found the overture to be one sided, but it felt the subject should be aired.

Overture 14: *On Responding to the Human Needs of Those Affected by the Crisis in Syria*. The WTG felt this overture was not well written, and the WTG does not favor the current government in Syria. But the WTG does feel concern for refugees. The WTG favors this overture for the purpose of getting discussion going.

Any commissioner may ask presbytery to consider concurring in any of the overtures. The effect of concurring is to permit the overture to be discussed by General Assembly. If a commissioner wishes to ask presbytery to consider concurrence, the commissioner **MUST** have copies of the full text of the overture at least for the presbytery moderator, the stated clerk, and the presenter of the overtures so that the full text may be read to presbytery. The commissioner makes a motion to consider. If the motion is seconded, the commissioner will read the entire overture to presbytery. Overtures may be debated, but not amended.

- **Overture 7**: On Streamlining the Sale of Property Given to a Congregation as a Gift to Fund Ministry and Mission. No, there are good reasons for having presbyteries review property sales. In addition, this provision would be difficult to administer.
- **Overture 12**: On Amending G-2.0503 to Change the Designation Honorably Retired to Retired. This overture would eliminate the possibility of honoring former active ministers as honorably retired. No. Our committee likes being able to honor folks.
- **Overture 15**: On Amending G-3.0303 by Adding a New Paragraph g. Regarding Authority to Convene Meetings: This overture seeks to give presbyteries the authority to convene session or congregational meetings when disorder in the congregation threatens the viability of the church. No. The Book of Order already grants presbyteries the authority to call a congregational meeting [G-1.0502] and a session meeting [G-3.0203] whenever it feels that is appropriate. This would limit authority that our presbytery has used judiciously, where the rationale of the overture implies the purpose is to expand the authority of presbytery.
- **Overture 17**: *Regarding the status of the University of Tulsa as a Presbyterian related university.* This overture would establish a Task Force to engage in conversation with U. of Tulsa leaders to discuss recent curriculum changes there which diminish emphasis on the humanities. The overture wishes the Task Force to review criteria for being a Presbyterian-related institution.

- **Overture 18**: On Amending G-2.0804 Regarding PC (USA) Paid Family Leave. This overture seeks to place explicit and detailed mandatory requirements for family leave in the Book of Order. The 223rd General Assembly assigned a task force to bring to the 224th G.A. a family leave proposal. This overture would probably be considered in light of the task force's recommendations.
- **Overture 19:** On Amending D-10.0303 and D-10.0302 Regarding Accused's Rights to Be Notified: This overture seeks to include notification of both the accused and the accuser of the disposition of a disciplinary investigation and then makes editorial changes to the test regarding the same. Since the Rule of Discipline Task Force is bringing to the 224th General Assembly, this overture would probably be considered in light of its recommendations.
- **Overture 20:** On Amending W-4.0403 regarding Laying on of Hands at an Installation: This overture would seek to de-emphasize the laying on of hands done at ordinations by those ordained to office, by inviting all in the congregation to lay hands on those being installed or commissioned.
- **Overture 21**: On Affirming the United Nations Framework Convention on Climate Change (Paris Agreement): This overture seeks public advocacy in support of the Paris Agreement on Climate Change, urging Presbyterians to contact their legislators in favor of supporting the agreement.
- **Overture 22**: On Amending G-2.1002 Regarding Ordaining a Commissioned Ruling Elder as Minister of the Word and Sacrament. This overture seeks to expand the pool of potential pastoral candidates for small and rural congregations by permitting presbyteries to ordain and ministers of Word and Sacrament commissioned lay pastors who have served six years or more. The proponents see the obstacle to recruitment of candidates as the time and cost of seminary. The proponents do not take into account the difference between minimum terms of call for ministers of Word and Sacrament and commissioned ruling elders. If CRE's were ordained as ministers of Word and Sacrament, their calls and contracts would be subject to minimum terms of call, which would put them out of reach of the congregations they had been serving.

The WTG will ask for thirty minutes of time on the January 25 presbytery docket. Any commissioner may ask presbytery to consider concurring in any of the overtures. The effect of concurring is to permit the overture to be discussed by General Assembly. If a commissioner wishes to ask presbytery to consider concurrence, the commissioner **MUST** have copies of the full text of the overture at least for the presbytery moderator, the stated clerk, and the presenter of the overtures so that the full text may be read to presbytery.
