DIRECTIONS to Milesburg



103 Turnpike Street Milesburg PA 16823 814-355-0890

From the Northeast or Northwest:

Follow I-80; Take exit 158 (Milesburg) and travel south on US 220/150.

Travel approximately 1.5 miles, take off ramp to the right towards Milesburg (144/150 south), follow the clover leaf around to the right and merge onto 144/150.

Travel approximately 1/2 mile over an iron bridge and into the town of Milesburg. After crossing the bridge, travel approximately 2/10 of a mile and turn right onto Commercial Street. The Milesburg Presbyterian Church will now be immediately to your left. Parking will be in the small lot on your left, along the roadside and in a larger lot to the right by following a large white sign with black letters stating "Public Parking".



OR take I-99 and follow the directions below

From the South and west

- 1) Follow I-99 North to either the Port Matilda Exit (US Route 322/Eagle Valley Road (Old Route 220) or
- 2) past State College to the Bellefonte Exit (PA Route 150 North)
 - a. Exiting I-99 at Port Matilda (Exit 61): Go right at end of off ramp, turn right onto N. High Street; travel ½ mile to traffic light, turn left onto Eagle Valley Road (Old 220) and follow it north towards Milesburg approximately 15.5 miles upon which you will pass the Sheetz and the Bald Eagle Area schools on your left. Travel approximately one more mile and then exit right onto PA 144/150 South towards Milesburg and Bellefonte.

Travel approximately 1/2 mile over an iron bridge and into the town of Milesburg. After crossing the bridge, travel approximately 2/10 of a mile and turn right onto Commercial Street. The Milesburg Presbyterian Church will now be immediately to your left. Parking will be in the small lot on your left, along the roadside and in a larger lot to the right by following a large white sign with black letters stating "Public Parking".

b. Exiting I-99 at Bellefonte(Exit 78B): Follow I-99N /US 220 N and take Exit 78B towards Bellefonte. This will merge you onto PA Route 150 North. Follow PA 150 North down the hill and into Bellefonte. Spring Creek will be on your left. Travel through Bellefonte keeping Spring Creek on your left and follow PA 150 North past the Kwik Fill Gas Station (on your left and into Milesburg. You'll pass the Milesburg Methodist Church (Keep going!) travel about 1/10 of a mile and turn left just after the Milesburg Presbyterian Church and onto Commercial Street. Parking will be in the small lot on your left, along the roadside and in a larger lot to the right by following a large white sign with black letters stating "Public Parking".

From the South East; (i.e. Lewistown Area)

Follow US 322 West from Lewistown towards State College. At Potter's Mills, keep left and stay on US 322 West, do not take 144 N to the right. Follow 322 West and stay to the left after the speed drops to 45 MPH near Boalsburg. Avoid "Business 322/Boalsburg" ramp on the right. Continue on US 322 West which will now be a four lane highway (Mount Nittany Expressway). Take the I-99 N/US 220 N ramp towards Bellefonte and I-80. Follow directions 2b for exiting at Bellefonte

CONSENT AGENDA

What is a consent agenda?

A consent agenda is made up of items that may be considered routine business that need action, but are unlikely to require debate. Items for inclusion on the consent agenda must be sent out in advance with the pre-presbytery mailing and clearly marked for the consent agenda.

Why is a consent agenda useful?

When the consent agenda is called for, the moderator will call for a motion to approve the entire consent agenda in one vote, thus saving presbytery time for items requiring more discussion.

BUT What if I wish to debate, discuss, ask for clarification on some part of the consent agenda?

Simply, rise to be recognized and request that that item be removed from the consent agenda. One person's request is all that is required. No second is required, no vote need be taken to remove the item.

Do not give the explanation of your concern, need for clarification, points to be emphasized or opposed at this time. The item will come up for consideration at the time when the remainder of that committee's report is made, and you will be afforded the opportunity to speak to the motion at that time.

ACTUAL TERMS OF CALL ADDITIONAL INFORMATION & NOTES

Alexandria: Ernie Walls: Called for full time pastoral service, 65% of which will be devoted to Alexandria and 35% to Sinking Valley. Sinking Valley will compensate the Alexandria session each month \$2625 plus any vouchered expneses incurred by the pastor in fulfilling his obligations to Sinking Valley, along with 35% of the pastor's vacation, cont. educ., study leave and denominational service, etc.

Bedford: Jack Miller: Cell phone reimbursement up to \$1000 vouchered. FSA employee contributions \$4300.

Bellefonte: Debbie Johnson: Called for full time pastoral service, 50% of which will be devoted to Bellefonte and 50% to Milesburg. Each congregation is responsible for 50% of her terms of call.

West Kish: Ela Robertson: Contacted for full time pastoral service, 50% of which will be devoted to West Kishacoquillas Presbyterian Church and 50% to St. John's Lutheran Church. Each congregation is responsible for 50% of her terms of service.

Clearfield: J. Hopper. Also \$1000 sabbatical leave expenses; \$750 cell phone

MountainTop Parish: Leanne Gill Peters: Continuing education: The commissioned ruling elder is encouraged to engage in continuing education. Participation in events beyond one-day workshops should be determined in advance in consultation with the Council. Reimbursement of costs associated with continuing education should be negotiated in advance with Council. Cash salary: On Sundays when the part-time CLP is serving as worship leader and when special worship services are scheduled salary payment will be \$280 per week. On weeks the CLP is not leading worship services the salary payment will be \$205 per week.

East Kish: Pat Roller: Also \$1000 Health Flexible Spending Account.

State College: Dean Lindsey: 3 months sabbatical after 6 years.

Winburne: Martha Bloom and Gary Jewart, Co-CLPS: Each week the preaching CLP receives \$137 and the non-preaching CLP receives \$48. Continuing education expenses paid with advance approval by session.

Presbytery of Huntingdon: K. Joy Kaufmann: Call for 2/3 time nine months of the year and full time three months of the year. Full and part-time weeks to be determined in consultation with Personnel Committee. Board of Pensions calculated for part-time. Additional conference expenses of up to \$1250.00 and Ecumenical activities of up to \$250.00

MEMORIAL TRIBUTE ROLAND R. EMOND

Roland Rene Emond was a faithful child of God, filled with gratitude for the grace which had been extended to him, disciplined to follow the paths laid out before him, clear and rock solid in his understanding of theology and ecclesiastical practice. Roland was born March 18, 1947 in Worcester, Massachusetts to Janette and Roland Emond, Sr. Although raised in the Roman Catholic tradition, like many young people who grew up in the 1960's, he fell away from the practice of religion, as he was called by his country to serve in the United States Navy on the U.S.S. Jouett, during the Vietnam crisis. It was not until several decades later that he picked up the mantle that had been set before him, as he again found his Saviour, this time in a Presbyterian Church.

God was clearly calling Roland to act on his faith. Indeed Roland wrote in his statement of faith, "In light of my own salvation, made possible through an indwelling of Your Holy Spirit, and made known to me by Your Word, I commit my life to Jesus as Lord--mind, body and soul--and pledge myself to walk in discipleship." He entered seminary and in 1993, on the 18th of April 1993, he was ordained to the ministry of Word and Sacrament in the Presbyterian Church U.S.A. by North Central Iowa Presbytery as pastor of the Burt and Woden rural yoke of congregations. From there, he took the helm of a rural yoke in Kansas, Leoti and Tribune.

Roland understood that "call" is not always easy or comfortable. He drove long distances between the congregations of his vokes because that was what God called him to do. He came before this presbytery to be examined, again driving long distance and ending up in our furthest most point up at Krislund on a November afternoon in 2005, which was delayed again by long conversations. He didn't complain. He was officially entered onto our rolls January 1, 2006 as pastor of Coalport and Irvona, over which he was installed on March 19, 2006. He served there until August 1, 2015, when he took honorable retirement. He was active in the affairs of presbytery, serving on our trustees for six years, including three as chair. He moderated the Houtzdale session and, with Gary Jewart, chaired the administrative commission to close and wind up the affairs of the Snow Shoe church. He was not just a name to fill a slot, but personally worked to help shut down and turn off utilities and deal with property issues. When his term on the trustees concluded, he did not withdraw, but accepted election to another hard-working committee, COM. There Roland was active in shepherding our persons under care, as they sought to discern God's call to them to ordained ministry and their preparation for it. Roland did this while equally joyfully devoting himself with his wife Jodi to raising their daughter Rachel, whom they homeschooled. If Roland ever missed committee meetings, it was only because Rachel's appointments took priority. If he had regrets, it was that he had not had the opportunity to do the same for his older children—Julie, Chris and Patrick. He was happiest being a partner with others—preaching at Curwensville, moderating session at Houtzdale, mentoring lay pastor Rick Ginter.

Irvona Clerk of Session Cate Hutton wrote "After retirement he found joy in preaching regularly in the Curwensville and Houtzdale Presbyterian Churches. He stated that he was most happy working under the Presbytery of Huntingdon. He found his place for him and his family to call home. For the yoke churches of Coalport and Irvona, we found peace in Rev. Roland R. Emond that our yoke would stand firm. He came to serve both. He was a Bible-teaching minister and not afraid to stand up for Jesus. He was always sharing God's Holy Word.

He was great for visiting the sick and hurting no matter the cost. He made sure folks knew that they had a Saviour while sharing his faith. He brought many to Christ Jesus and Baptized some while on their death bed. He did, while here on earth, what God called him to do: teach and preach the Word."

Lay Pastor Rick Ginter, who is a member of Coalport Presbyterian Church, knew him well. Rick recalls: "It was late 2005 when I first met Rev. Roland R. Emond, Jr, the called pastor to the Coalport and Irvona Presbyterian Churches. Little did I know that not only would he be my pastor but mentor and good friend. Over the next thirteen years I came to appreciate this God-fearing man who held strong biblical views and shared them with whoever would give him heed. He was one who lived, breathed, and taught the five Reformed "solas". However, when we first talked he did not affirm all of the Five Points of Grace (Calvinism) but within the next couple of years he did fully affirm them.

Worship for Roland was to be very traditional but not so far as singing the Psalms exclusively (and without accompaniment by any musical instrument). He definitely didn't want to be apart of a service with a "Praise Band". In his words, "That would undo me!" Another area that he was adamant about was what was called "dangerous music". He shared with me an article from "Virtue Magazine." In that article he affirmed his understanding that "hard rock and heavy metal music can damage the mind and soul, classical music has been proven to regenerate brain cells, soothe and relax the body." Once when our local ministerium was having a Cantata he affirmed his opposition to having contemporary music in such a worship environment.

In regards to the various meetings that we Presbyterians attend he stated he didn't mind them as long as they were not on a Saturday. Multiple times he expressed his dislike of giving up his Saturday for a meeting (I believed it took away from his final preparation for Sunday). Such meetings brought out these expressions: "I loath...", "I dislike...", "Ugh, a Saturday meeting!"

He was not only well versed in Scripture but in many other areas. One such area was his knowledge about heating with wood. He said he and Jodi "burned only wood for the first ten years of our marriage." In the Coalport manse the Session put in a new stove insert into the existing fireplace and Roland remarked it was "like old times; less the hard work of cutting, hauling and splitting wood; but I miss that part more, since I need the exercise."

Roland shared his view that he "would like to see congregations become more family centered." this was in regards to the idea of house churches and seeking "a Biblical form of worship", he also stated, "I have often recommended a small house congregation as an alternative to closing down a congregation [on the other hand] there is more of an opportunity for ministry and outreach when there is a formal, and healthy, congregation removed from the home."

He had an active mind and expressed that when he wrote, "I have been thinking (my head never really shuts down) ..."

He expressed his concern about Satan "keeping the world in denial" and then gave an example of those who are denying the Holocaust. He quoted Edmund Burke: "All that is necessary for the triumph of evil is for good men to do nothing."

He attended the Wee Kirk Conferences for multiple years but he became concerned that "each year they got more sloppy in their teachings, but always to the Right of the Left, while woefully to the Left of Christ." He then continued with a remark about his age: "Oh well, I am 60 and that much closer to glory; may God keep [me] in His grace and continue to give me the grace to endure in my witness." He also expressed this about his physical health when he turned 60: "Life is tough and then you get to spend time with various doctors. I suppose our generation will send our respective doctors on lots of wonderful vacations."

In regards to a difficult session problem I had he offered this: "My advice is to say as little as

possible in the way of arguing; especially when it comes to repeating stuff that has already become stated. In one sense [it is] a moot issue. Those who are apostate will not agree no matter how clear we may explain it; so to respond is simply, 'casting pearls before swine.'"

Prayer of the mature Christian "is that we simply focus on God and wait on Him and His decisions, and glorify Him regardless of what He decides. In expressing our gratefulness over what God does with us, and living-out our trust in Him, we are used by God to further His kingdom."

I truly loved and appreciated this Reformed evangelical conservative man. I'm a much better disciple of Christ having walked with him!"

He died February 4, 2019, after a prolonged bout with prostate cancer. He was survived by daughter Rachel Emond, and step-children Julie, Chris, and Patrick Zeisel, and his wife Deborah "Jodi" Ault Zeisel, and his mother Janette.
